What is this product?

Type

An Alternative Investment Fund consisting of a number of investment management agreements between investors and Thompson Taraz Managers Limited, managed in parallel.

Objectives

The Oxford Technology and Innovations EIS Fund provides an opportunity for Investors to participate in a portfolio of technology businesses with significant growth potential. These may include – but are not limited to – companies in the life sciences sector, engineering, physics, materials, chemistry, software, IT, AI and the green energy sector. It is anticipated that several of the investments may well be University of Oxford spin-out companies; however, we will not limit ourselves only to university spin-out ventures and may invest in companies based throughout the UK.

By investing in the Fund, UK taxpayers may be able to benefit from the reliefs provided by the Enterprise Investment Scheme (EIS).

Intended retail investor


The fund is only appropriate for investors prepared to take on a higher level of risk of loss of capital to obtain a potentially higher return and who are prepared to stay invested for the minimum recommended holding period. In addition, an investment in the Fund is limited to retail investors who have been advised by an authorised financial advisor or who are certified High Net Worth or self-certified Sophisticated Investors and who have successfully completed the application process in full.

Recommended Holding Period

The recommended holding period is five years and the product cannot be easily realised.

What are the risks and what could I get in return?

The risk indicator assumes you keep the investment for at least 5 years. You may not be able to sell the investment early or you may have to sell at a price that significantly impacts how much you get back.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest £10,000. The figures are estimates and may change in the future.

This table shows the impact on return per year (Moderate Scenario)

How long should I hold it and can I take money out early?

Recommended minimum holding period: 5 Years

The minimum period (in order to qualify for EIS relief) is 3 years from the point of the final investment however the recommended minimum holding period is 5 years and this product cannot be easily realised. This means it is difficult to estimate how much you would get back if you attempt to realise your investment early. You will

either be unable to realise your investment early or you will have to pay high costs or make a large loss if you do so. Certain withdrawal rights exist as described in the Information Memorandum, however these do not permit the withdrawal of cash which has already been used to make investments.

How can I complain?
