What is this product?

Type

An Alternative Investment Fund consisting of a number of investment management agreements between investors and Thompson Taraz Managers Limited, managed in parallel.

Objectives

The Sovereign IHT Solution (the "Fund") offers the opportunity to participate in the commercial potential of one or more UK companies in the music publishing or asset-backed lending sectors. The companies will be sourced and monitored by the Investment Consultant, Sovereign Media Group Ltd.

By investing in the Fund, UK taxpayers may be able to benefit from Business Relief ("BR") from Inheritance Tax ("IHT").

Intended retail investor

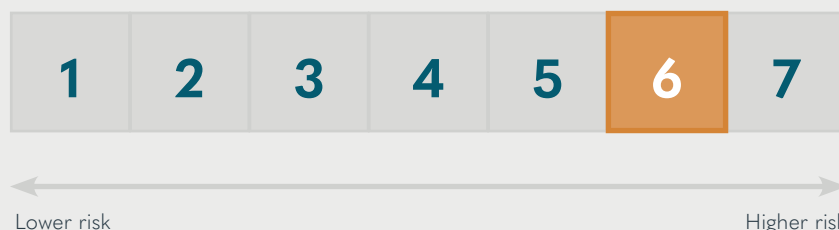
The fund is only appropriate for investors seeking relief from IHT who are prepared to take on a higher level of risk of loss of capital and who are prepared to stay invested until the point of death. An investment in the Fund is limited to investors who have been advised by an authorised financial advisor that the investment is suitable and who have successfully completed the application process in full.

Recommended Holding Period

The recommended holding period for the purposes of this document and the calculations below is five years and the product cannot be easily realised in all circumstances.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the investment for at least 5 years. You may not be able to sell the investment early or you may have to sell at a price that significantly impacts how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the products will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as a 6 out of 7, which is the second highest risk class.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest £10,000. The figures are estimates and may change in the future.

All costs above are expected to be paid by Investee Companies which would not therefore reduce the tax relief available to Investors. How long should I hold it and can I take money out early?

Recommended minimum holding period: 5 Years or until death

The required minimum holding period (in order to qualify for Business Relief) is until death, and at least 2 years from the point of investment. For the purposes of this document and the calculations above, the recommended minimum hold period is 5 years. If you make withdrawals, you will lose the Business Relief on the amount withdrawn and retain it only on the investment held at the point of death.

Withdrawals will be facilitated where possible, however this product cannot be easily realised in all circumstances and it is difficult to estimate how much you would get back if you attempt to realise your investment early. You may be unable to realise your investment early or you may have to pay high costs or make a significant loss if you do so. Certain withdrawal rights exist as described in the Information Memorandum, however these do not permit the withdrawal of cash which has already been used to make investments.
